As the Screening Committee was called at a very short interval, Fact sheets of the proposals could not be prepared by the concerned Section. The proposals received from the offices of CP and Member (YA) were seen during the meeting and decisions taken. The eight cases of Ex-post facto sanction as placed by the Research & Study Cell were also considered and approved.

JS stressed the need for reviewing the norms for Seminars/ Workshops/ Research Study/ Public Hearing/ LAP/PMLA so as to ensure the proper conduct of the programmes and utilization of financial assistance. The identification of NGOs who do not complete the studies or submit sub- standard study reports, also needs to be undertaken at the earliest to ensure proper utilization of funds. In addition, norms may be relaxed for State Women Commission and Government agencies.
