## Editor's Column

It is heartening to note the overwhelming public response of shame, sympathy and outrage after the unspeakable treatment of a young Tanzanian student in Bangalaru, who was stripped and beaten by a raging mob. Strongly condemning the heinous incident, NCW has taken suo-motu cognizance of the incident, seeking action-taken report from the police.

The Prime Minister's office also made direct intervention by asking the Ministry of External Affairs to work in tandem with the Tanzanian High Commission and take all possible steps to ensure that the aggrieved gets justice. Since then, five men have been arrested. It is hoped that others, who were equally

responsible for this dastardly act, would be promptly brought to book.

It is indeed a matter of shame that attacks like this on African students have become frequent. However, the Karnataka Home Minister has trivialized the incident by calling it an incident of road-rage, set off by the death of a local woman, who had been earlier run over by a

# Combating Racism

Sudanese driver and hence it had nothing to do with racism. If that is so, then why would a mob attack the occupants of a car that came upon the scene much later? Is it not because the occupants had dark skin? If this is not racism? What is? There is no

denying that we look down upon people with dark complexion; we look askance at our brothers and sisters from the North East because they look different; we comment on the dark skin of women from Kerala; we defend midnight raid carried out on Nigerian and Ugandan women by a minister.

These are nothing but shameful acts of racism and violence against different communities and races. Unless we are able to curb this scourge of racism, particularly, contempt for black people, and mete out severe punishment to the perpetrators, such recurring incidents of racism will adversely affect our relationship with African countries and tarnish India's image globally.

## **Important Decisions**

- The Bombay High Court has enhanced punishment of a Pune youth, who threw acid on a BPO employee for rejecting his marriage proposal. A two-judge division bench held that the seven-year prison term given to the accused in the 2005 acid attack on a 21-year-old girl was not deterrent enough and sentenced him to life imprisonment. The HC has ordered the police to trace the accused, who is absconding after jumping furlough in 2007. The court said that he has endangered her life and left her incapable to marry any other person. The punishment of merely seven years imprisonment for this inhuman and cruel act is definitely a miscarriage of justice and sentenced him to life imprisonment.
- The Karnataka High Court has dismissed a District Judge, who was serving in Belagavi district and terminated his services on charges of sexually harassing women employees, after an enquiry that, took nearly four years to complete.

# From the Legal Cell

The National Commission for Women organized an Interactive Meeting with Rajasthan, Maharashtra, Madhya Pradesh, Punjab, Haryana, Uttarakhand, Chhattisgarh, Delhi, Jharkhand and Uttar Pradesh State Commissions for Women at Ahmedabad.

The objective of the meeting was to strengthen linkages with the State Commissions and discuss actions taken on the recommendations of the earlier interactive meetings, as well as various problems faced by women in different spheres of their lives such as trafficking, female infanticide, desertion in NRI marriages, violence against women, deprivation of women's rights, unregulated sale of acids, etc. The meeting also tried to find solutions to avoid repetition of complaints before the State Commissions as well as NCW.

## Meeting on Social, Economic and Political Empowerment of Women in North-East States

The Sub-Committee meeting on 'Social, Economic and Political Empowerment of Women in North-East States' was held on 19th February, 2016, in New Delhi. The meeting, chaired by NCW Chairperson Lalitha Kumaramangalam, was attended by Chairpersons, Member Secretaries, resource persons of all the eight North-East States and a team from TISS headed by its Director, Dr Parusuraman.

In her inaugural address, the Chairperson set the tone by emphasizing that the primary agenda of the meeting was not just to identify problems faced by women of N-E

states but more importantly to ascertain appropriate sustainable and action able solutions, which can be incorporated in the policy recommendations of the Commission for the development and empowerment of women of the North–East States.

She observed that the women of North-East States face varied challenges depending on the environment they live in. She stated that there was a genuine vaccum of primary data on the actual condition of women of the North-East and that was the reason for the extensive research study undertaken by NCW. She reiterated that the central

The findings, she hoped, would give an overall picture as well as highlight the specifics particular to individual States. The inaugural session was followed by State-wise presentations on the findings of the study and proposed recommendations. What emerged from the presentations was a certain commonalty in the challenges faced by women and the strategies to be adopted to combat problems faced by each State. The issues discussed by the States comprised women's social status in the society, economic position, position in politics, health and violence against women.

She said that violence against women generally occurred in families due to the drunken behaviour of the husbands. She urged the participants to immediately dial 100 and register their complaints in police stations.

Later, the Chairperson released two video documentaries titled "Developing India" and "Path of Success" and 11 booklets on legal literacy and flash cards on electoral literacy.

In response to a question, she explained how individuals and organizations can contribute in spreading awareness about curbing domestic violence and the resources available for the same.

A woman in Firozabad in UP sent her bridegroom packing when he reached the venue of their wedding totally drunk. Community elders held a Panchayats to find a way out but at the end, the groom's side had to return embarrassed as the woman allegedly threatened to end her life if she was forced to marry him.

Seeing him in such a state, the woman told her parents and siblings that she would not marry him. When they tried to force her, she threatened to end her life. Thereafter, the elders from both sides unanimously decided to call off the wedding.
